According to **Timo Buetefisch**, **CEO and co-founder of Cooltra**, "Askoll is a key partner in Cooltra's growth plans. This new acquisition will strengthen our fleet in France and Italy, thus reinforcing our position as a leader in sustainable two-wheeled mobility in Europe".
